



### **OPERATION METHODS:**

- 1. Connect the hosepipe: Insert the hose pipe into the suction end & lock it (Fig 1)
- 2. Connect the extension tubes to the curved end of hose pipe (Fig 2)
- Connect the different accessories to the extension tube for different cleaning purposes: Floor brush (adjust to the type of ground) for carpet or floor (Fig3); 2-in-1 nozzle for wall surface, corners or space between furniture, etc.(Fig4); Upholstery cleaner for sofa, curtains and bed.
- 4. Insert the plug into the power socket which satisfies the specification on the rating label and press the on/off switch pedal to start the vacuum cleaner. (Fig 5)
- 5. Cord rewinding: Press the auto cord winder to rewind the power cord automatically. (Fig. 6)



### **MAINTENANCE:**

- 1. Replacement of dust bag: When the dust bag full indicator turns red, remove the dust bag, empty it and replace it.
- Open the front cover (Fig 1)
- Remove the dust bag from the holder and empty the dust (Fig 2)
- Put the cleaned dust bag on to the holder again (Fig 3)
- 2. Cleaning the air outlet filter: Remove the air outlet filter by hand, wash it with water and dry it before using it next time. If the filter is broken, please change it. (Fig 4,5,6)







#### **SAFETY DIRECTIONS:**

- 1. Before the 1st time use, read the user manual carefully & keep it handy if required in future.
- 2. Make sure the dust bag is properly installed.
- 3. Make sure the power supply is 220-240V,50/60Hz
- 4. Do not vacuum water and other wet spills.
- 5. Do not vacuum burning material and ashes.
- 6. Do not use the machine without a dust bag.
- 7. Please change the dust bag immediately when it is damaged.
- 8. Do not store or use the machine close to high temperature places.
