






1. Make sure the following items are included in your package.




2. For a look at the various buttons on your speaker, view the graphic below.



- 1. Bluetooti
- 2. Volume –
- 3. Volume +
- 4. Power Button
- 5. AUX IN Port
- 6. LED Indicator Light
- 7. Charging Port

3. **Charging:** In order to charge your speaker's internal battery, connect one end of the included USB cable to the Charging Port on your speaker. Connect the other end to a USB port or AC charging adapter. The LED Indicator Light turns red when charging, and turns off when fully charged. Charging may take up to 3 hours.




4. Pairing Your Speaker With a Bluetooth Phone

-Press and hold the Power Button to power on your speaker. When first powered on, the LED Indicator Light will slowly flash. It will soon start flashing rapidly to indicate that your speaker is in pairing mode.

-Go to the Bluetooth Manager of your Bluetooth device. Search Bluetooth devices and select "mini inMotion" to start connecting.

-If required, enter the PIN code "0000" and confirm the entry.

Once paired, you will hear your speaker audibly say: "You are now paired, enjoy." The LED Indicator Light will slowly flash once your speaker is paired.



5. Listening to Music on Your Speaker

Play/Pause

Press the Bluetooth button to get music from your audio source to play or pause.

Increase/Decrease Volume


Press and hold the Volume + or Volume - buttons to increase or decrease the volume.

Disconnecting Bluetooth

Press and hold the Bluetooth button to unpair your speaker from a Bluetooth audio source.

Powering Off

Press and hold Power Button to power off your speaker. The blue LED Indicator Light will dim completely.



6. Using Your Speaker During Phone Calls

Answering an Incoming Call

To answer an incoming call, quickly press the Bluetooth button.

Ending a Call

To end a call, quickly press the Bluetooth button, and the call will be disconnected.

Adjusting Volume

By pressing the Volume Up or Volume Down buttons you can increase or decrease the volume of the phone call.


